



Independent Assurance Report

We were engaged by Mitsui Mining & Smelting Co., Ltd. (the “Company”) to undertake a limited assurance engagement of its Mitsui Mining & Smelting (Kamioka) LBMA Responsible Silver Guidance Compliance Report (the “Compliance Report”) for the year ended 31 March 2022. The assurance scope consists of the Company’s Compliance Report.

The Company’s responsibility

The management of the Company is responsible for the preparation and fair presentation of its Compliance Report in accordance with the requirements of the LBMA Responsible Silver Guidance (the “Guidance”). This responsibility includes establishing appropriate risk management and internal controls from which the reported information is derived. We do not accept or assume responsibility to anyone other than the Company for our work, or for the conclusions we have reached in the assurance report.

- Inquiring management to gain an understanding of the Company’s processes and risk management protocols in place
- Inquiring relevant staff responsible for the preparation of the Compliance Report
- Site visit to Kamioka Mining & Smelting Co., Ltd.
- Assessing the suitability of the policies, procedures and internal controls that the Company has in place to conform to the Guidance
- Reviewing a selection of the supporting documentation, including silver supplier counterparty due diligence file and transaction’s documentation
